Job's Daughters Scholarships Awarded



Foreign Correspondence Committee By Earl L. Emerson, Jr., Chairman

Your Committee on Foreign Correspondence relies on the Standards of Recognition report presented by the Commission on Information for Recognition of the Conference of Grand Masters of Masons in North America. This Commission was created to gather, collate and from time to time, revise information on Grand Lodges in other lands. The Standards of Recognition used by this Commission are as follows:

• Legitimacy of Origin.

• Exclusive territorial jurisdiction, except by mutual consent and/or treaty.

• Adherence to the Ancient Landmarks – specifically, a belief in God, the Volume of Sacred Law as an indispensable part of the furniture of the lodge and the prohibition of the discussion of politics or religion.

The Commission applies these standards to all requests from the Foreign Grand Lodge Jurisdictions who seek recognition before a recommended conclusion is reached.

The Grand Lodges recognized by the Grand Lodge of Delaware are all of the Grand Lodges in the United States plus: AFRICA-Babon, Ivory Coast, South Africa; ARGENTINA; AUSTRALIA-New South Wales, Queensland, South Australia, Tasmania, Victoria, Western Australia; AUSTRIA;BELGIUM (Regular);BOLIVIA; BRAZIL-Alagoas, Bahia, Ceara, Golas, Mato Grosso, Minas Gerais, Para, Paralba, Parana, Pemambuclo, Piaul, Rio de Janeiro, Rio Grande do Norte, Rio Grande do Sul, Rodonia, Roralima, Santa Catarina, Sao Paulo, Sergipe, Tocantins; CANADA-Alberta, British Columbia, Manitoba, New Brunswick, Newfoundland and Labrador, Nova Scotia, Ontario, Prince Edward Island, Quebec, Saskatchewan; CHILE; CHINA(Taiwan); COLUMBIA-Barranqulia, Bogota, Occidental, Santander; COSTA RICA; CUBA (in Havana); DENMARK; DOMINI-CAN REPUBLIC; ECUADOR, ENGLAND; FINLAND; FRANCE (National); GERMANY (United): GREECE (A;F&A.M.); GUATEMALA; HAITI; HUN-GARY; ICELAND (National); INDIA; IRAN (in exile); IRELAND; ISRAEL; JAPAN; LUXEMBOURG (Grand Ducy); MEXICO-Benito Juarez (Coahulla), Valie de Mexaco, York; NETHERLANDS; NEW ZEALAND; NICARAGUA (united); NORWAY; PANAMA; PERU; PHILLIPINES; PORTUGAL (Legal); PUERTO RICA; ROMANIA; RUSSIA; ELSALVADORE (Cuscatian); SCOTLAND; SPAIN; SWEDEN; SWITZERLAND (Alpina); TURKEY; URUGUAY; VENEZUELA; and YOGOSLAVIA (Regular).

Some foreign Grand Lodges have made requests to be recognized by this Grand Lodge and are being examined at this time. When a report has been established, either favorable or unfavorable, those requests for recognition are presented to the Grand Lodge of Delaware for action.
